Psychoanalysis is a theoretical framework of human development, psychological functioning, psychopathology, and change processes, as well as a distinctive model of psychotherapy. Psychoanalysis was the first modern Western system of psychotherapy, and most other forms of therapy evolved out of psychoanalysis were strongly influenced by it, or developed partially in reaction to it. Although psychoanalysis began with Freud's writing and lectures and the work of a small group of colleagues primarily in Vienna, by the time of Freud's death in 1939 it began to grow into an international movement with important centers in Vienna, Zurich, Berlin, Budapest, Italy, France, England, the United States, and Latin America, which each contributed its own unique influence to.
