Testifying

Georgia State OMB (8 July 1998)—discussed implications of implementing sentencing guidelines similar to those in the federal system.

Maryland House of Delegates Judiciary Committee (20 October 1999)—expert witness on Maryland House Bill 736 that would allow citizens to carry concealed weapons.

South Carolina Lottery Impact Commission (22 August 2000)—discussed Georgia's lottery-funded merit-based aid program as South Carolina considers adopting similar legislation.

Klein v. Leis (Deposed October 2000; Testified at Trial November 2001)—testified as an expert witness for the plaintiff. In January 2002, Judge Robert P. Ruehlman ruled in favor of the plaintiff and that the Ohio concealed carry laws violated the Ohio Constitution.

Georgia State Office of Planning and Budget (June 2002)—discussed my research on HOPE Scholarship with Governor’s office officials who are considering changing the program.
