Submit your manuscripts today! The panmictic indices are the complements of the fixation indices:  $HIS_{ij,k=1} - FIS_{ij,k}$ , (7a)  $HIT_{ij=1} - FIT_{ij}$ , (7b)  $HST_{ij=1} - FST_{ij}$ , (7c). The fixation indices satisfy some simple constraints. From (4b), (5b), and (6b) we see immediately  $FIS_{ij,k}, FIT_{ij}, FST_{ij} \leq 1, i \neq j$ . (8) These fixation indices can be negative.
