Marge Tanney from Our Shepherd welcomed the attendees to the meeting.

The Reverend Dr. Evan Gaertner, Senior Pastor of Our Shepherd led the assembly in the opening devotion. Dr. Gaertner based his devotion on the meaning of the word Zion as his first call was to Zion Lutheran Church. Zion means "city of God". In Zion, everything is perfect: there is love, peace, joy, etc. at all times. Here we can only find delicious fruit in certain seasons; in Zion, fruit grows daily, plentifully, and is always delicious. All are welcome to this perfection.

President Lucie Witte called the meeting to order at 10:15 AM.

Minutes of the Spring general meeting, April 30, 2018, were approved with one correction and one addition. Glory Drum will make these changes and file the report. Report on file.

TREASURER'S REPORT

Treasurer, Wilma Wagner, presented her report. A question was raised regarding *the repeated* \$275 expenditures to the IRS. President Lucie explained this was for *three attempts* at filing paperwork to qualify the CLW as a 501-C3 tax-exempt organization. Report on file.

Allocation of Undesignated Funds

At the August Executive Committee meeting, the members voted to allocate \$6,225.00 from the Undesignated Fund to the Scholarship Fund to bring the total amount in that fund to \$11,000.00. This was then presented to the Board of Directors on August 20 for their vote and was approved for 18 students, each receiving approximately \$611.

Since August, an additional student has been accepted, raising the number of students to 19. In order to keep the Scholarship Fund at or near \$11,000.00, it is necessary to reduce the transfer of funds from Undesignated to Scholarship. To present this properly, President Lucie first requested the recommendation not be approved from the Board of Directors. A recommendation be made to accept the first proposal. A recommendation was made and seconded to do so. The vote was taken, and the recommendation did not pass. A new motion was then made by Gail Terey, seconded by Andrea Anderson, to accept the second proposal of allocating \$6,146.00 to the Scholarship Fund to bring the total to \$10,925.00. Each student would receive \$575.00. The assembly voted to accept the second proposal.

REPORTS OF OFFICERS

- President Lucie gave her report. She requested the Lutheran Center Association, of which we are a part, to update their website to show current officers of the CLW. She and Barb Collins met with Kelsey Pfau and Mike Pietila of the Christian Business Connection (formerly known as Lutheran Business Association) to discuss a possible joint venture. They would like to have a fund-raiser to establish a scholarship for a business student at Concordia University, Ann Arbor. No further action has been taken. Report on file.

She encouraged us to read about the candidates from reliable sources and not rely on the TV ads. Many of us were unaware the marijuana is far more potent than what was introduced in the 60s and 70s. Doris August explained why we no longer take clothing for Detroit Rescue Mission. If someone still wants to donate, contact Doris and she will be glad to pick up the items at your church. Also the LWR is not using Conrail this year to transport quilts but rather trucks. Conrail did not want the liability of delivering the items. The drop off centers are listed on her report. / 20+ Treasurer Report Templates. As the treasurer of a company or group, he or she is the person liable and responsible of the money flow that is happening inside of it. One way of listing its destinations is using a financial report template where all the costs, expenditures, revenue and income made in a month or year will be fully computed and shown in a systematic way so any reader will know any discrepancies when they saw it. You may also see report samples. Treasurer's reports are essential parts of organizing a business or organization's finances. They must follow a basic formula, but outside of that formula they are flexible documents that can change to meet specific needs. Basic Formula. Determine the starting balance. This is the amount of money the organization had at the beginning of the treasury period (usually reports are done every quarter or year).
